
OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. This prize includes two return flights from Auckland to Norfolk Island, 7 nights' accommodation at the South Pacific Resort Hotel and a Norfolk Island rental car. The winner must use the hashtag #loveairchathams on an Instagram post of one of Air Chathams destinations, Whakatāne, Whanganui, the Kāpiti Coast, Chatham Islands, or Norfolk Island to be eligible for the prize.
2. By participating in the hashtag #loveairchathams competition, you give Air Chathams permission to use your image on their website, social media, collateral and other promotional opportunities.
3. The Prize for the hashtag #loveairchathams competition is for 2 return flights from Auckland to Norfolk Island and 7 nights' accommodation on Norfolk Island only, and a rental car from Norfolk Island Rent a Car.
4. This Campaign is open only to those who can receive and use the prize if they are able to take the flight from Auckland International Airport. If they are not situated in Auckland, it will be their responsibility and cost to organise travel to Auckland International Airport. If they are situated in Whakatāne, Whanganui or the Kāpiti Coast, Air Chathams will provide return flights for two to Auckland to connect to the Norfolk Island flights. T
5. The travel period for this prize is from 1 April 2020 to 31 July 2020.
6. By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, you agree to accept the decisions of Air Chathams as final and binding as it relates to the content of this Campaign.
7. Entries will be accepted online starting 14 February 2020 and end on 15 March 2020. All online entries must be received by 5 pm 15 March 2020. The Prize must be used in the allotted period for travel and will expire on 31 July 2020.
8. The Campaign must be entered by using the hashtag #loveairchathams on an Instagram post of one of Air Chathams destinations, Whakatāne, Whanganui, the Kāpiti Coast, Chatham Islands, or Norfolk Island, or an Air Chathams aircraft in operation. The entry must fulfil all requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Air Chathams. You may enter more than once but you may get extra entries for sharing the competition on social platforms. You must provide the information requested. You may not enter by using multiple addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Air Chathams.
9. The Winner of the Prize (the "Winner") will receive return flights for two to Norfolk Island and 7 nights' accommodation. The specifics of the prize shall be solely determined by Air Chathams. No cash or other prize substitution shall be permitted except at Air Chatham's discretion. The prize is

nontransferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of the prize or transfer/assignment of a prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for Air Chathams to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation unless prohibited by law.
